Smoking/Alcohol consumption Rules

Identity Proof

- Indian nationals can present any government issued photo identity and address proof card e.g. driving license, passport, Aadhar card or voter ID card. PAN Card will not be accepted as the above.
- Also, please do keep handy proof of corporate affiliations, if you have made a corporate booking.

Extra Bed

Extra beds are available on advance notice, at a nominal additional charge.

Child Policy

One child up to the age of 6 years, sharing parent's bed, can stay on a complimentary basis, in the same room. For one child below 6 years of age, and one child between 6 and 12 years, we will provide an extra bed on chargeable basis in the same room. Breakfast is priced at Rs 350 per

child or can be paid as per actuals. For two children above 6 years of age, an additional room must be booked.

No visitors after 10:00 p.m. Visitors must notify Front Desk upon their arrival. Visitors must be accompanied by the registered guest at all times. Visitors are not allowed to use guest amenities. As a registered guest, you are responsible for your visitor at all times.

Hotel Policy
